

DECLARATION REGARDING MEMBERSHIP

With respect to the application for Club Affiliation Membership (the “**Affiliate Membership**”) in Saskatchewan Archery Association Inc. (the “**SAA**”) by _____ (the “**Club**”) for (year) _____.

Saskatchewan, do solemnly declare that:

1. We are the representatives of the Club and as such have personal knowledge of the facts and matters stated herein.
2. We are aware that Section 3.4 of the Bylaws of the SAA (the “**Bylaws**”), states:
 - 3.4 **Club Affiliation Membership.** *Club Affiliation Membership shall be granted to any group of archers who have formed an archery club with appropriate directors, officers and bylaws that conform in principle with the Bylaws of the Association provided that:*
 - (a) *The Club is in good standing and appropriate fees and dues have been paid; and*
 - (b) *All of the members of the Club have also become Adult or Youth Members, as the case may be, of the SAA.*
 - (c) *The Club does not have voting rights.*
3. We are aware that the SAA is the Provincial/ Territorial Association Member of Archery Canada (“**Archery Canada**”) as defined in the operating agreement between the SAA and the Federation of Canadian Archers Inc. (the “**Agreement**”).
4. We are aware that the Club’s Affiliate Membership in the SAA, as the Provincial Member of Archery Canada, automatically includes the Club and the members of the Club in Archery Canada’s “General Liability Insurance” program (the “**Insurance Coverage**”), and we are further aware that the “AC provincial/territorial member and AC affiliated club, associations or societies and individual and family registrants” (as defined in the Agreement) may obtain the benefit of this Insurance Coverage, but only if they are in good standing with the SAA.
5. We are aware that in order for the Club to be in good standing with the SAA and obtain the Insurance Coverage, the Club must comply with all Bylaws including, without limitation, Section 3.4, and that all of the members of the Club must be Adult or Youth Members, as the case may be, of the SAA.

6. We are aware that in the event the Club does not collect and submit SAA memberships fees for each and every member of the Club, then the Club is not covered by the Insurance Coverage and therefore, the Club, the Club's members and the Club's directors may be liable in the case of an accident.
7. We are aware that in the event the Club does not comply with all Bylaws including, without limitation, Section 3.4, the SAA will not support any SAA programs which the Club may run, including, without limitation: funding for the Club's athletes (including funding to attend competitions, Athlete Assistance grants and Future Best grants), Junior Olympic Program (including provision of badges and other support), MAP grants and shoot advertising.
8. All of the members of the Club have become Adult or Youth Members, as the case may be, of the SAA and therefore the Club is in compliance with Section 3.4 of the Bylaws.

And I make this solemn declaration, conscientiously believing it to be true and knowing that it is of the same force and effect as if made under oath, and by virtue of the **Canada Evidence Act**.
